**Proposal Abstract - please provide a *brief* overview of your proposal including the number of persons that will be served with this grant in the space below:**

The City building currently being used as the Senior Citizens Center of Saratoga Springs has significant drainage issues. This past year the City addressed these issues in the front of the building by adding a dry well and re-grading. The back of the building is unsafe ¾ of the year during the cold spring and fall days as well as the winter. Currently there is no proper drainage off the rear steps and building to the parking lot, the entrance into the rear of the building and sidewalk surrounding this area. The water drains off of the hill onto the sidewalk and refreezes creating an icy covered sidewalk. The senior population is already at high risk of falling, the current situation only escalates that. We have had people fall and bring this to our attention. This has also caused structural damage to the cement on the rear porch and entryway. In addition, the overhang above the rear steps needs to be rebuilt and gutters or an overhang built off the walkway. This project is not only a structural problem, but one of health and safety. The City engineers need to re-grade, add drainage piping, potentially a new dry well, new gutters and a new roof over the rear steps.

The Center services approximately 2,000 low to moderate income seniors per year. In addition the Center is an emergency warming shelter, public polling place, and provides space to other community members and groups such as AARP, Mayor’s Senior Advisory Committee, AA, Office for the Aging. In an emergency situation the Center can hold between 300-400 community members at one time and provide food and temporary shelter.
